3. Represents restricted stock units allocated pursuant to the Company's Management Stock Purchase Plan at a price per unit equal to \$19.57 funded by the deferral of receipt of director meeting and committee chair fees.

4. Includes 1,139.04 restricted stock units previously reported on Table I.

5. Represents matching restricted stock units, previously reported on Table I, allocated to the Reporting Person pursuant to the Company's Management Stock Purchase Plan equal in number to restricted stock units allocated to reflect the Reporting Person's deferral of a portion of his annual director retainer fee.

6. Restricted stock units are forfeited if Reporting Person's service as a member of the Company's Board of Directors is terminated prior to age sixty (60). Each restricted stock unit is converted to cash in an amount equal to the fair market value (200 day rolling average) of one share of the Company's common stock on the date of termination of the Reporting Person's service as a director of the Company.
